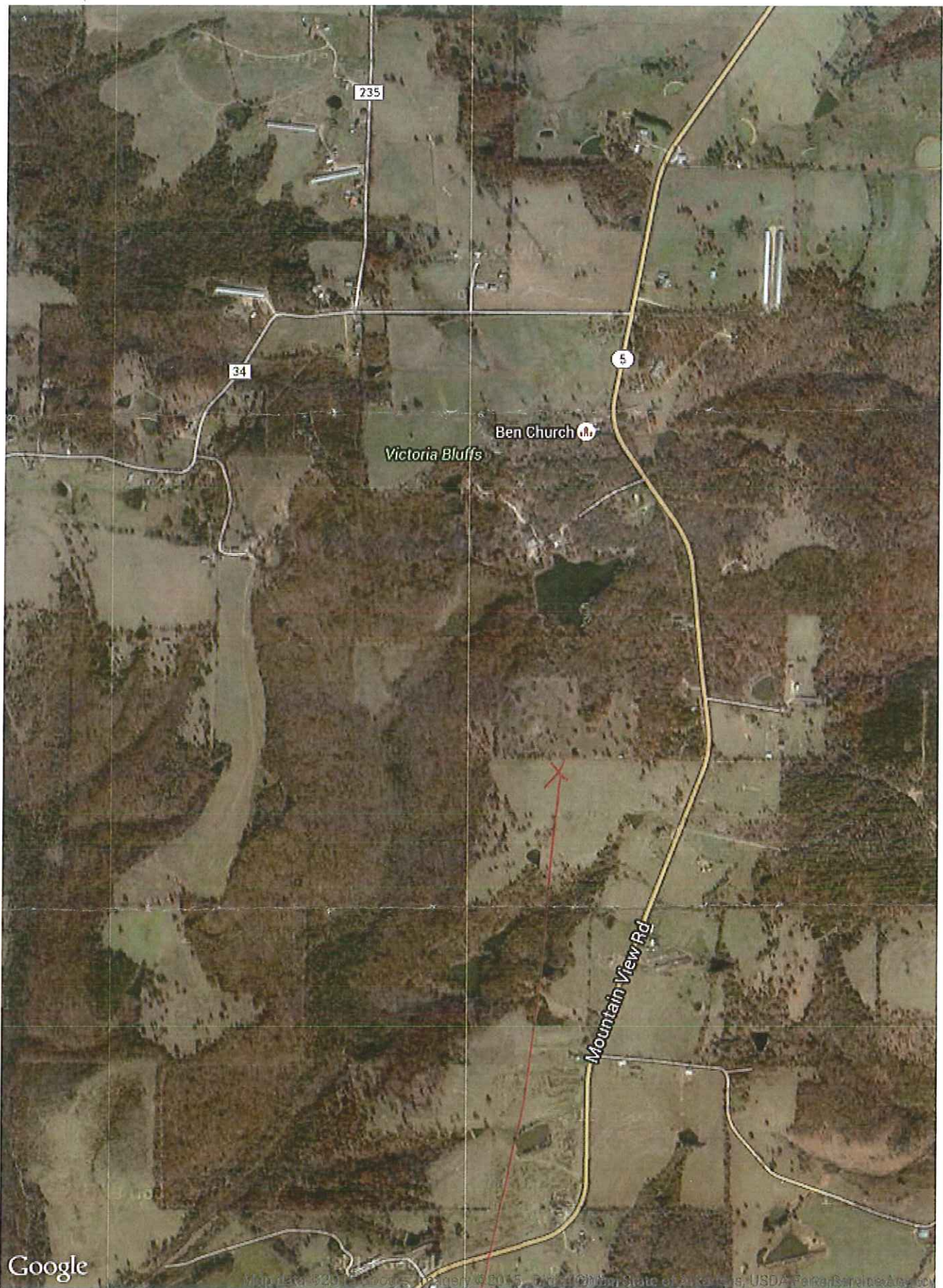
The U.S. Fish and Wildlife Service (Service) has reviewed the information supplied in your letter dated June 25, 2015, regarding the proposed construction of six poultry houses for Kevin Stair near the city of Drone in Stone County, Arkansas. Our comments are submitted in accordance with the Endangered Species Act (ESA; 87 Stat. 884, as amended 16 U.S.C. 1531 et seq.).

The Service concurs with your determination that the proposed construction may affect, but is not likely to adversely affect the Indiana Bat (*Myotis sodalis*), Gray Bat (*Myotis grisescens*), Northern Long-eared Bat (*Myotis septentrionalis*), Cave Crayfish (*Cambarus zophonastes*), Yellowcheek Darter (*Etheostoma moorei*), or Speckled Pocketbook (*Lampsilis streckeri*).

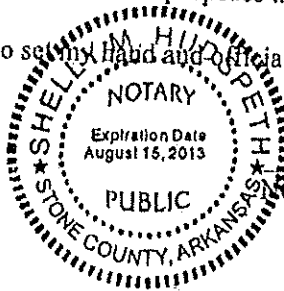

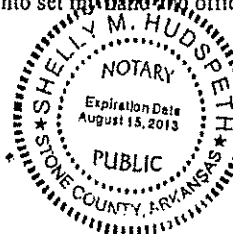
